2014 WEINTRAUB LECTURERS

THE HONORABLE HAROLD BAER, JR. began his judicial career in 1982 when he was elected to serve on the New York Supreme Court for New York County. He resigned from the Court in 1992 and was the Executive Judicial Of-

ficer at JAMS/Endispute until 1994, when he was inducted as a judge of the United States District Court for the Southern District of New York.

Prior to his election to the Supreme Court, he was in charge of litigation at a Wall Street law firm. Judge Baer was an Assistant United States Attorney and headed the Organized Crime and Racketeering Unit of that office in the 1960s. He returned as First Assistant U.S. Attorney and Chief of the Criminal Division in 1970. Judge Baer served on the Mollen Commission, a Special Unit of the New York State Commission of Investigation and the State Commission on the Governmental Operations of the City of New York. He was the first Executive Director of the Civilian Com-

plaint Review Board of the New York City Police Department and has been active in New York State, City and County Bar Associations.

In addition to hundreds of published opinions, Judge Baer has written extensively on legal topics, with some 50 books, pamphlets and articles to his credit. He graduated *magna cum laude* and Phi Beta Kappa from Hobart College and from the Yale Law School in 1957.

THE HONORABLE GARY S. STEIN served from 1985 to 2002 as an Associate Justice on the New Jersey State Supreme Court. He wrote more than 365 published opinions during his tenure, the sixth longest in the State Supreme

Court's history. Prior to his appointment to the Court, he served during the Kean Administration as Director of the Governor's Office of Policy and Planning from 1982 to 1985.

Additionally, Justice Stein has been Paramus Borough Attorney and counsel to the New Jersey Election Law Revision Commission. He also is a former counsel to the Teaneck Board of Adjustment, former chairperson of the Bergen County District Ethics Committee, and former chairperson of the Supreme Court Committee on Complementary Dispute Resolution.



Justice Stein is a fellow of the American Bar Foun-

dation, as well as a member of the Bergen County, New Jersey State, and American Bar Associations. Justice Stein is a graduate of Duke University, where he received his B.A. in 1954 and his J.D. with distinction in 1956. He is currently special counsel at Pashman Stein and teaches election law and health care law as an adjunct professor of Rutgers–Newark Law School.
